

Violations Bureau Schedule of Offenses and Fine

Pursuant to Supreme Court Rule 37.495 the undersigned Municipal Judge of the City of Lake Ozark hereby orders that the following designated offenses may be payable to the City of Lake Ozark Violations Bureau. A person may pay the specified amount of the fine and costs to the Bureau in person, by , mail or through an electronic payment system before the court date and time for the initial court appearance. Said payment constitutes a guilty plea and waiver of trial.
